## **AREAS OF EXPERTISE**

Working in Australia, Europe and the United States, Jeff has gained 12 years of high-level diverse experience in architecture and urban design. Jeff's primary expertise is in the design of residential and mixed-use projects, including town centre development, transit-oriented development, master planned communities, and a variety of residential building types. He has become expert at delivering design solutions that achieve thermal efficiency (passive solar) and a strong sense of place (urban design). Jeff is a founding Director of Evoke Design Group, a consulting group offering specialized expertise in sustainable urban design, building design and town planning.

Highlights of Jeff's career include leading roles on major award-winning projects. In 2001-03, he acted as lead urban designer in the conceptual building design and structure planning of Mirvac's multi-award winning high-density community 'The Peninsula' at Burswood. In 2007, Cockburn Central, Landcorp's flagship transit-oriented development, won the coveted PIA Minister's Award. Jeff played a critical role in the project, leading a multi-disciplinary team to deliver the Cockburn Central structure plan, subdivision, and built form codes. In 2008, Jeff designed an eco-retirement village in Chidlow that was recently a Finalist for the HIA Greensmart Concept Design Award.
